- a broader discussion about the next steps that are needed for the Recommendation Response and Road Map, and what future visions lie beyond that.

The idea is to move forward on this journey in a constructive, collaborative way.

The more administrative elements of the meeting will be dealt with only at the end of the day. We will use the end of one of the last plenaries to sign off on the formal, practical steps needed by work groups 4 and 5

FIRST CALLePpSO WORKSHOP

“European Patient Summaries and ePrescription Services”

10:45 – 18.00

Workshop organisation: Veli Stroetmann, empirica

The workshop will focus on the European Patient Summary (PS) and ePrescription services (ePr), including their data content and the legal and functional requirements, as they have been elaborated within epSOS. The aim is to reach a common level of understanding to allow for effective interaction during and after the workshop, to provide valuable stakeholder input to epSOS, and to contribute to eHealth developments in Europe.

The following thematic areas will be discussed:

1) Legal and Regulatory issues (LR)

The objective is to introduce the legal and regulatory constraints and explain epSOS strategy in scoping and expanding (short term and long term perspective), explain practical solutions and main areas of action like NCPs (National Contact Points), outstanding professional issues, patient consent, etc.; raise key issues for discussion, identify gaps and opportunities for strengthening the practical approach through collaboration with EU and national stakeholders.

2) European Patient Summary and ePrescription services

The aim is to introduce epSOS definition of PS and ePr, the use cases identified, agreed priorities, key issues like min-max data sets; functional requirements; scalability). Organisational, health system and health professional challenges as well as semantic issues will be highlighted.

After detailed presentations and Q&A sessions in all three thematic areas, two break-out sessions will be organised to enable work in small working groups allowing for participation in at least 2 groups on different topics.

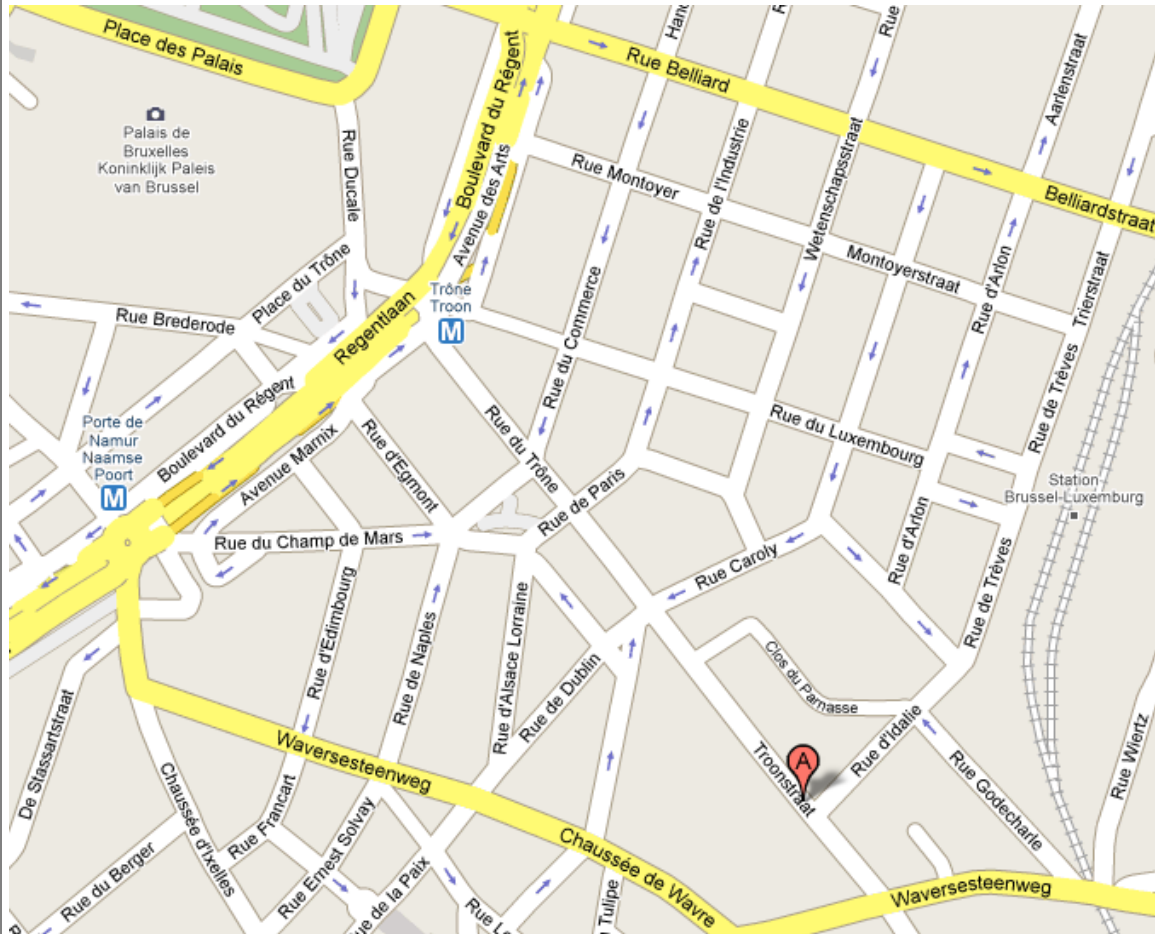
